**2021 RULES & CONDITIONS** 

#### **ENTRY**

# Guidelines

- Applicants are required to enter via the Accept'd Platform. All applicants must submit an entry form and a video recording of their nominated programme (see Repertoire Guidelines for more information).
- Entries may only be submitted online.
- Entry is open to all Australian citizens and permanent residents.
- It is a condition of the awards that all broadcast and television rights of your performances in any stage of the competition are freely available to MOST and the ABC.
- By entering the YPA competitors agree to comply with the Rules & Conditions of the YPA.
- If a competitor violates the Rules & Conditions, MOST reserves the right to disqualify them from the YPA.
- The YPA are open to keyboard and all orchestral instruments.

# **Entry Form**

- The entry form requires a competitor to provide information, including:
- Name, address and contact details;
- Social media contacts (e.g. Facebook, Twitter, Google+, Instagram, Tumblr, etc.);
- Curriculum Vitae;
- Study details;
- Future plans;
- Performance history;
- High resolution headshot/photograph (2Mb or larger);
- Proof of age, citizenship or residency;
- Completed Repertoire Form for all three (3) rounds in performance order;
- Consent & declaration;
- Payment.

# Fees & Penalties

- A non-refundable entry fee of \$150AUD applies.
- The Entry Fee is payable through the Accept'd platform and will be charged in Australian Dollars.
- An additional non-refundable fee of \$30AUD will apply for entries received after entries close but before the late-entry date of Wednesday 14 April.

#### 2021 Dates

- Dates at any stage will not be altered to meet the needs of individual applicants.
- MOST® reserves the right to change the dates of all stages of the competition. All details may be subject to change without notice.

# **COMPETITION STRUCTURE**

# Stages of the Competition

- The competition will take place over three stages: Round One, Semi-Finals and Finals.
- Round One will be conducted online and will require applicants to submit a pre-recorded video of their nominated repertoire (see Repertoire Guidelines).
- The Semi-Finals Stage will be conducted online but will be recorded 'live' at an ABC studio in the Semi-Finalist's capital city. Semi-Finalists will perform for the Adjudication Panel via video link at a prescribed time. Semi-Finalists must ensure they put aside two days before the Semi-Finals for rehearsal at the venue. The performances at the Semi-Finals will be released for viewing by the general public in the weeks following.
- The Finals Stage will be conducted online but will be recorded 'live' at an ABC studio in the Finalist's capital city. Finalists will perform for the Adjudication Panel via video link at a prescribed time. The performances at the Finals will be live-streamed for the general public. Finalists must ensure they put aside two days before the Finals for rehearsal at the venue.
- The Winner will be announced on the evening of Sunday 21 November 2021.

#### REPERTOIRE

# General Repertoire Regulations

- Any questions regarding suitability of any repertoire selections must be discussed and resolved before
  the closing date for entries.
- Competitors may be required to nominate an alternative work for performance at any stage if the original choice is deemed unsuitable as determined by the Chair of the Adjudication Panel.
- Competitors may be required to make cuts to any part of their nominated programme as determined by the Chair of the Adjudication Panel.
- Entry forms must include all repertoire chosen for all rounds of the awards.
- Entrants must ensure that their choice of work for the Finals is available as a piano reduction.
- Works which require more than one soloist are not permitted at any stage of the competition.
- A printed copy of repertoire is to be provided to adjudicators at the Semi-Finals and Finals.

- The total duration of a Competitor's performance in the digital recording submitted for Round One shall not exceed thirty (30) minutes.
- The total duration of a Competitor's performance in the Semi-Finals shall not exceed forty-five (45) minutes.
- The total duration of a Competitor's performance in the Finals must exceed fifteen (15) minutes and not exceed forty-five (45) minutes
- Failure to adhere to time restrictions may result in disqualification.
- All repertoire is subject to final approval by the Adjudication Panel. It is encouraged that repertoire be performed from memory when appropriate.

# Digital Entry Repertoire

Competitors must prepare a balanced and diverse recital programme of 30 minutes in length,
 representing a variety of periods and styles and at least one work which displays the high degree of virtuosity commensurate with the standard of the YPA.

#### Semi-Finals Repertoire

- Competitors are required to prepare a new, balanced and diverse recital programme of 40 45 minutes in length, representing a variety of periods and styles. This programme should include one work by an Australian composer and at least one work which displays the high degree of virtuosity commensurate with the standard of the YPA.
- Complete movements of larger works are allowed.
- The programme for the Semi-Finals should not include items performed in Round One.

#### Finals Repertoire

- Each competitor must nominate at time of entry a complete concerto or other comparable work written for performance with orchestra and available as a piano reduction.
- This work must be at least 15 minutes in duration.
- The concerto for the Final Round will be performed with piano accompaniment.
- Because of Covid 19 restrictions and the uncertainty of Orchestra availability, Finalists will perform the final round with piano accompaniment.

# ACCOMPANIMENT

#### Semi Finals Accompaniment

Competitors must engage at their own expense an accompanist for the Semi-Finals.

#### **ADJUDICATION**

# **General Information**

- Adjudicators for each round of the YPA will be published on our website (see Adjudicators page).
- In all matters that may occur during the competition, decisions of the YPA Adjudicators and/or Music &
  Opera Singers Trust Ltd (MOST®) shall be final.

# Adjudication of Round 1: Digital Entries

- A Panel comprising the Chair of the Adjudication Panel and a minimum of 4 panel members representing relevant musical disciplines assess the digital submissions.
- The Panel will choose, from the shortlisted candidates, six (6) competitors to progress to the Semi-Finals Round.
- Please do not contact Music & Opera Singers Trust to enquire about results. No results will be given
  out by telephone.

#### Adjudication of Round 2: Semi-Finals

- A Panel comprising the Chair of the Adjudication Panel and a minimum of 4 panel members representing relevant musical disciplines will adjudicate the Semi-Finals.
- The Panel will choose, from the shortlisted candidates, three (3) competitors to progress to the Finals Round.
- Results of the Semi-Finals will be announced on Sunday 7 November.

# Adjudication of Round 3: Finals

- A Panel comprising the Chair of the Adjudication Panel and a minimum of 4 panel members representing relevant musical disciplines will adjudicate the Finals.
- The Finals Adjudication panel may include a non-voting representative from MOST®.
- Results of the Finals will be announced at the conclusion of the live stream on Sunday 21 November.

# Travel & Accommodation

- It is not envisaged that the 2021 competition will require travel; however, any travel undertaken for any stage of the competition will be at the Competitor's expense.
- Transport and insurance for instruments will not be provided by MOST at any stage of the competition.
- YPA and MOST® shall not have any responsibility for Competitors' loss and/or damage during the competition and competitors should purchase their own insurance where relevant.
- Competitors are responsible for their own health and injury insurance, as well as loss or damage of the instrument or luggage in case of accident, fire or theft during travel.

# **Prize Conditions**

- All awards given by the competition must be drawn within three (3) years of the recipient winning unless an alternative agreement is reached.
- Requests for funds must be made in writing, with a budget detailing the proposed use. Funds will not
  be released until the budget is approved. Funds are usually dispensed in a series of monthly
  instalments.
- The winner of the YPA is required to provide a report to MOST® within 12 months of the receipt of the award.
- The report can be in the form of (1) a written report (not to exceed 1200-1500 words, with photographs where possible; or (2) a video report (not to exceed 10 minutes). The report should highlight the experiences and/or benefits that the award has had on his/her career.
- A number of prizes & opportunities may be awarded to a Competitor at the discretion of the Adjudicators at the Semi-Final or Finals.
- Recipients of awards ("the recipients") are strongly encouraged to acknowledge the relevant prize giver with a letter of thanks. The YPA will supply the appropriate contact details.
- YPA and MOST® take no responsibility for the acceptance of awards, which involve overseas travel. This decision is taken solely at the discretion of the recipient. Recipients are advised to check the current status of the country in question with the Australian Government's Department of Foreign Affairs at the time of travel.
- The recipient of any award is reminded that the cash component is a form of income. Any enquiries regarding tax should be referred to the Deputy Commissioner of Taxation, an accountant or a registered tax consultant.
- YPA and its administrator MOST® act as coordinator of the prizes and opportunities and cannot accept responsibility if any provider is unable to fulfil its obligations in any form.
- Some individual prizes and opportunities are awarded at the discretion of the individual sponsor or provider.
- If the recipient of any award connected to funds elects not to proceed with that award, the associated funds must be forfeited and may be made available to another Finalist.
